Sealed bids will be received by Owner at the Administrative Offices at Teton County Extension Office 235 South 5th East1, Driggs, Idaho 83422, until 2:00 p.m. (M.D.T.), **September 29, 2010**. The bids will then be opened and read aloud at 4:00 p.m.

All bids shall be made in accordance with forms referenced to and/or made a part of the proposed contract documents. Bids shall be submitted in a sealed envelope with annotation **“Fairgrounds Arena”** and addressed to:

Centennial St. Driggs, ID 83422 (Phone: 208-354-5335) for a **non-refundable cost of \$25.00 per CD or a non-refundable cost of \$75.00 per paper set, which must be paid at time prior to pick up or shipping**. Please allow 24 hour notice for printing.

The Contractors, in submitting their respective bids, acknowledge that such bids conform to all Idaho State Statute requirements.

Each bidder must deposit bid bond security with the bid, payable to Teton County Fair Board, in accordance with the Instruction to Bidders.

The successful bidder shall be required to furnish a contract Performance Bond, and a Labor and Materials Payment Bond, each in the amount of one hundred percent (100%) of the contract price as originally bid or subsequently modified. The cost of the bonds shall be included in the Contractor's Bid Proposal.

No bidder may withdraw its bid until 30 days after the bid opening.

The Owner reserves the right to reject any and all bids or parts thereof, and to waive any irregularities of any bid. The Owner also reserves the right to award the contract to such responsible bidders as may be determined by the Owner.
