

GUIDELINES FOR FILING FOR AS AN INDEPENDENT FOR COUNTY OFFICE

2016 General Election

This information is subject to amendatory change during the 2016 session of the Idaho Legislature. If changes occur, an updated version will be made available.

Filing Period

1st day to file	February 29, 2016	
last day to file	March 11, 2016	Received by 5:00 PM in the County Clerk's office.

Materials Required: Declaration of Candidacy & Petitions

*** Declaration of Candidacy - Form EC-11**

1. Print your name exactly as you wish it to appear on the ballot.
2. **You must be registered and affiliated with no political party (i.e. unaffiliated). (Contact the County Clerk to verify that you are not affiliated with a political party (i.e. unaffiliated).)**
3. Signature of candidate must be notarized.

*** Petitions - Form EC-11A (may be reproduced)**

1. **5 signatures** to be verified by the County Clerk to be signatures of registered electors prior to acceptance of the Declaration of Candidacy.
2. All petitions must be complete (i.e., the top portion must be filled in and the circulator must have their signature notarized on the bottom portion of the petition prior to being filed with the County Clerk.)

Campaign Disclosure

1. All candidates must certify a political treasurer.
2. Candidates must file an Appointment and Certification of Political Treasurer (C-1 form) prior to receiving any contributions or making any expenditures. The C-1 form is available from and must be filed with the County Clerk's Office.

INSTRUCTIONS

CANDIDATE: This Declaration of Candidacy must be accompanied by the Petition of Candidacy signed by not less than 5 electors of your specific district or County. It must also be submitted to the County Clerk during candidate filing between February 29th and March 11th, 2016.

COUNTY CLERK: Upon receipt of this Declaration of Candidacy:

1. Verify the Candidate is registered and is affiliated as an Unaffiliated voter.
2. Verify that the Petition of Candidacy is signed by not less than 5 electors.
3. Verify that the 5 electors are properly registered electors.
 - a. If the electors are required to be residents of the candidate's sub-district, verify that the electors are in the correct sub-district.
4. Stamp or write the date and time of receipt on the front of this document.
5. Complete the statement below.

This petition must be filed with Declaration of Candidacy in the office of the County Clerk during the time prescribed by law prior to the Primary Election by candidates for all political parties for all county offices. The statutory minimum number of signatures must be verified by the county clerks prior to filing. The submitted petition must have affixed thereto the names of at least five (5) but no more than ten (10) qualified electors who reside within the appropriate county or commissioner's district.
