

2017 Candidate Filing Guidelines

May 16, 2017 Election

Districts scheduled to hold Candidate Elections:

Auditorium	Recreational Water and Sewer
Highway	School
Hospital	Water and Sewer
Library	Weather Modification

Filing Deadline:

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 9th Friday before the Election (March 17, 2017).

Declarations of Intent for Write-In candidates must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (April 1, 2017).

Withdrawal Deadline:

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (April 1, 2017).

November 7, 2017 Election

Districts scheduled to hold Candidate Elections:

Cemetery	Fire Protection
Cities	Recreation

Filing Deadline:

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 9th Friday before the Election (September 8, 2017).

Declarations of Intent for Write-In candidates must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (September 23, 2017).

Withdrawal Deadline:

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (September 23, 2017).

Required Forms for Filing for May or November Elections:

Declaration of Candidacy – Form EC-1A

1. Print name exactly as you wish it to appear on the ballot.
 - a. Enter the District Name, Office Title, Term of Office, Election and Date of Election, and Candidate Residence Address.
2. Signature of Candidate must be notarized.

Petition of Candidacy – Form EC-1B

1. Print name of Candidate.
 - a. Enter the Office Title, Filing Deadline, District or Zone Name or Designation, Candidate Name and Office Title, and Date of Election.
2. Circulator must collect signatures of at least 5 eligible voters within the Candidate's Zone or District.
3. Signature of Circulator must be notarized.

CLERK OF THE DISTRICT: Upon receipt of this Declaration of Candidacy:

1. Verify that the Petition of Candidacy is signed by not less than 5 electors.
2. If the Petition of Candidacy was not verified by the County Clerk prior to submission to your office, contact the County Clerk's Election Office to verify that the 5 electors are properly registered electors.
 - a. If the electors are required to be residents of the candidate's zone, verify that the electors are in the correct zone.
3. Stamp or write the date and time of receipt on the front of this document.
4. Complete the statement below and transmit a copy of this Declaration of Candidacy to the County Clerk for ballot preparation.
