



TETON COUNTY SOLID WASTE & RECYCLING

On 09/30/2019, The Board of Teton County Commissioners has established the following schedule of fees (including out of county fees) for waste being delivered to the Teton County Transfer Station located at 1088 Cemetery Road, Driggs, ID 83422

Customers are required to show proof of current residency in Teton County, Idaho or Alta, Wyoming; otherwise out of county fees will apply:

Hours of Operation: Tuesday Through Friday: 8 A.M. TO 3 P.M.
Saturday: 8 a.m. to 1 p.m. **CLOSED: Sundays and Mondays**

Procedure for using Transfer Station: ALL vehicles must weigh in and out. Please follow our green and red traffic signals when entering and exiting the scale house. All loads are subject to a random inspection by the Weigh master and/or Staff.

TIRES: \$0.083/Pound (\$166/Ton) or: By Count instead of weight; Pickup & Car Tires are \$5 Each tire; Truck Tires are \$10 Each Tire

OUT OF COUNTY TIRES: \$0.083/pound \$166/Ton or: By Count instead of weight; Pickup & Car Tires are \$6 Each tire; Truck Tires are \$14 Each Tire

DEAD ANIMALS FEE: \$0.0075/pound (\$15/ton)

OUT OF COUNTY DEAD ANIMALS FEE: \$0.025 cents/pound (\$50/ton)

FRIDGES/FREEZERS/AC UNITS: \$80 per ton + \$35 each

OUT OF COUNTY FRIDGES/FREEZERS/AC UNITS: \$132 per ton + \$35 each

DEFINITIONS:

HOUSEHOLD WASTE - Waste produced by a household or a business doing normal, every-day activities at the location shown on their “tax receipt.”

NON-HOUSEHOLD WASTE – (Unsorted) All other waste, including waste produced by contractors performing construction or landscaping work, and waste produced by households or businesses conducting one-time cleanup or construction activities.

SORTED WASTE - Any waste brought to the transfer station that will be divided by the hauler into the following different material categories:

Please make sure all sortable materials are “clean” and separated with no other materials attached to them, i.e.: drywall with wood attached or wood with metal attached. No cloth material attached. Items with mixed material are unsorted

MIXED LOADS:

If your load is a mixed load, meaning sorted with household, you will be charged by weight according to the fees above: (You can weigh twice if you have a mixed load and want to save money; if you don’t weigh for different materials then the highest rate will be charged)

HOUSEHOLD HAZARDOUS WASTE:

The County currently does not accept household hazardous waste. Household hazardous waste is defined as any substance that will no longer be used for its intended purpose and exhibits any of the following characteristics; it’s flammable, reactive with other chemicals to emit toxic gases, or becomes explosive; it’s corrosive or toxic to humans and animals. This includes; antifreeze, acid-based products, ammonia- based cleaners and photo chemicals, flammable liquids such as paint, brake fluid, hydrogen peroxide, nitrites and nitrates, flammable solids such as adhesives, glues, waxes and silicone sealants, aerosols, poisons, pesticides and asbestos containing materials.

Teton County Idaho will reimburse up to \$150/year of cost for materials taken to the Teton County Wyoming Household Hazardous Waste Disposal Facility with proper receipt submitted to the Weigh master or at the courthouse. Teton County will only reimburse County Residents for these cost. Facility (To make an appointment please call: 307-733-7678).

Teton Solid Waste Staff may assist with unloading material as a courtesy when available. Please make sure you have adequate manpower to unload your material upon arrival. Employee assisted unload should not be an expectation.

****NOT RECYCLABLE:** Notebooks, Magazines, Phone Books, Packing Paper in any form, Paper Bags and Brown Paper are House Hold Garbage

GLASS:

- Bottles and Jars
- Rinse all Glass Bottles and Jars to be recycled

(Glass Bottle and Jugs must have lids removed)

- No window panes
- No drinking glasses or ceramics

CARDBOARD- CORRUGATED:

- **NO pizza boxes or food residue**
- Cardboard needs to be folded flat along with all packing material removed. ANY Cardboard larger than 2 feet x 4 feet should be also be cut down to a smaller size

*** GREY BOARD** (Cereal boxes, Beer and Pop Boxes, Egg containers, etc.) is Not considered Cardboard. It needs to be placed in the appropriate location. (This is NOT a mixed paper product) It is a Household Garbage Item.

**** STYROFOAM:** Teton Solid Waste **Does Not Recycle Styrofoam** in any form at this time. ALL Styrofoam is considered Household trash.

Plastics Bottles Only(Separated)

- # 1's & # 2 bottles or jugs. NO lids
- The bottle neck MUST be narrower than the base
- Must be Rinsed

****NOT RECYCLABLE:**

Plastic Food Container, Plastic Grocery Bags, Plastic Wrap, Bubble Wrap etc. is House Hold Garbage

E-WASTE:

- Televisions: None Tube Flat Screen Only
(Tube style TV/All Computer Monitors are House Hold Garbage and are not Recyclable)
- Cell phones
- iPods/MP3 players
- Digital Cameras
- PDA's and palm pilots
- Computers
- Printers/Fax
- Ink Cartridges

RECYCLING MATERIALS INCLUDE:

Sorted Waste: Any waste brought to the transfer station that will be Sorted by the hauler into the following different material categories and properly disposed of into appropriate collection sites:

Sorted Items Include:

METAL:

- Washers
- Dryers
- Dishwashers
- Bicycles W/ tires
- Metal roofing
- Tin
- Copper
- Metal furniture
- Steel

WOOD:

- UN treated posts/fencing
- Wood chips
- Saw dust
- Painted
- Plywood
- Composite
- Wood furniture
- Logs

MANURE:

MOTOR OIL ONLY:

Not accepted: Antifreeze,
Brake Fluid

BRUSH:

- Full trees/branches
- Xmas trees (NO FAUX)
- Brush waste

GRASS:

- Clippings
- Weeds of all kinds
- Straw/Hay w/o strings

CONSTRUCTION(C&D):

- CLEAN Sheetrock
- CLEAN asphalt
- CLEAN Concrete
- CLEAN Soil
- CLEAN Rock
- CLEAN Brick/cinder block
- CLEAN TILE
- CLEAN PORCELAIN

WIRE:

- Metal fencing/posts separated

Please make sure all sortable materials are "clean" and separated no other materials attached to them, i.e.: drywall with wood attached or wood metal attached. No Cloth material attached. Item with mixed materials are unsorted.
